Winter Driving

It is that time of year when driving conditions deteriorate, try incorporating the following precautions to better navigate the winter roadways.

Remove snow and ice accumulation from your vehicle; this includes not only your windshield and back window but your head lights, brake lights and hood. Clean snow off your roof also, snow can fly off your roof and endanger those behind you.

Know your vehicle. Before you enter traffic, test your brakes on the road conditions. Antilock brakes should not be pumped, non-antilock brakes should be pumped to avoid sliding. It is important to know how your vehicle performs on snow and ice.

Go slow. Give yourself extra time to get to your destination, and leave extra distance between you and the vehicle you are following.
